#### PUBLIC CONSULTATIONS ON THE PROPOSED THE NATIONAL TOURISM POLICY AND TOURISM (AMENDMENT) BILL, 2024

The Ministry of Tourism and Wildlife has developed a draft National Tourism Policy and the Tourism (Amendment) Bill, 2024.

The National Tourism Policy seeks to review the Sessional Paper No. 1 of 2010 in order to inter alia provide for management, marketing and regulation of the tourism sector while the Bill seeks to amend the Tourism Act, Cap. 381 in order to inter alia harmonize it with the Constitution and address emerging issues in the tourism sector.

This is therefore to notify all stakeholders and the general public and any other persons likely to be affected by the proposed Policy and Bill, that the Ministry shall hold public hearings on the above documents in accordance with the following schedule:
