



### INVITATION TO TENDER

#### TENDER FOR PROPOSED CONSTRUCTION, INSTALLATION, TESTING AND COMMISSIONING OF 10M<sup>3</sup> DOMESTIC BIOGAS PLANTS USING COW DUNG

1. The Ministry of Energy and Petroleum, State Department for Energy invites sealed tenders from eligible candidates for Proposed Construction, Installation, Testing and Commissioning of 10m<sup>3</sup> Domestic masonry biogas plants, using cow dung as the feedstock. The works will be carried out in eighteen (18) lots as shown below: -

2. Tendering will be conducted under Open National Competitive Method using a standardized tender document. Tendering is open to all qualified and interested Tenderers. Tenderers will be allowed to tender for one or more lots.

3. Qualified and interested tenderers may obtain further information and inspect the Tender Documents during office hours 0900 to 1700 hours at the address given below.

A complete set of tender documents may be obtained by interested tenderers electronically from the State Department for Energy Website [www.energy.go.ke](http://www.energy.go.ke) and the Public Procurement Information Portal <http://www.tenders.go.ke>. Tender documents obtained electronically will be free of charge.

6. Tenders shall be quoted in Kenya Shillings and shall include all taxes. Tenders shall remain valid for 154 days from the date of opening of tenders.

7. All Tenders must be accompanied by a tender Security of Kshs 100,000 for each lot quoted. Tender Security **MUST** be in the form of Bank Guarantee or Insurance bond from a reputable financial institution recognized by Central Bank of Kenya or PPRA and valid for at least 180 days from the tender opening date. Firms falling under Access to Government Procurement Opportunities (AGPO) will be required to fill the Tender Securing Declaration Form

8. The Tenderer shall chronologically serialize all pages of the tender documents submitted. The documents should be either hardbound or tape bound copies.

9. Completed tenders must be delivered to the address below on or before **9<sup>th</sup> April, 2025 at 10.00 A.M.** Electronic Tenders will not be permitted.

10. Tenders will be opened immediately after the deadline date and time specified above or any deadline date and time specified later. Tenders will be publicly opened in the presence of the Tenderers' designated representatives who choose to attend at the address below.

11. Late tenders will be rejected.
