- Copy of Valid Registration Certificate with National Construction Authority Electrical and Mechanical Engineering Service Contractor and Valid Contractor Annual Practicing Licenses **NCA 8 and Above (Electrical and Mechanical Works Contractor)**.
- Main Contractor may be allowed to use a Sub-Contractor for Electrical and Mechanical Works where the procedurally Sub-contracted and attaching Sub-Contracting Agreement, Business Registration or Incorporation Certificate, KRA PIN, Tax Compliance Certificates and NCA Registration and Annual Contractor Practicing Licenses of the Sub-Contractor.
- Duly filled Form of Tender
- Duly filled Confidential Business Questionnaire
- Self-declaration that the person / tenderer is not debarred in the matter of the Public Procurement and Asset Disposal Act 2015.
- Self-declaration that the person / tenderer will not engage in any corrupt or fraudulent practice.
- Declaration and commitment to the Code of Ethics.
- Must provide a Tender Security of **kshs. 100,000.00 (One Hundred Thousand Shillings Only)**
- The Tender Price must include **Public Procurement Capacity Building Levy of 0.03% of the value of the signed contract exclusive of applicable Taxes**.
- The Tenderer shall chronologically serialize all pages of the tender documents submitted.
- Submit Original Tender Document and a Copy. The Original Tender shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the tenderer.
- Proof of adequate Equipment either owned or leased and Key Personnel.
- Proof of works of similar in Nature, complexity or magnitude.

Failure to meet these requirements will render the bid non responsive in the minimum qualification criteria category and hence no further evaluation (Technical and Financial) on such a bid will be undertaken.
